

HIGH MOUNTAIN HUNTS LLC. OF NEW MEXICO HUNT CONTRACT

STEP 1: Create a New Mexico Game and Fish account

Go to wildlife.state.nm.us and create an account. Fill out your personal information and let us take care of the rest for you. HMH handles all applications in the NMDGF draw system for its clients. We will submit the application on your behalf using our outfitter number to increase your chance of a successful draw! **\$75 application fee applies.**

If you want to reserve a landowner tag in the event you don't draw, send a \$5,500 non-refundable deposit with application. We will still put you in for the draw. If you are successful in the draw your deposit will be applied to your hunt.

Landowner tags sell quickly, and they may not be available after the draw results are published.

In the event you are unable to attend the hunt with a landowner tag deposit we will apply for it till the next available time we can hunt together; no refunds will be issued.

The New Mexico Department of Game and Fish (NMDGF) offers a limited number of quality tags in designated units. We hunt only the best units for high success on trophy-caliber bulls. Applicants can mix dates, units, and weapon choices to better their odds. The NM draw is a pure lottery, there are no preference points. The units we specialize in are known to have some of the biggest bulls in the State.

The NMDGF charges the full license fee up front for all species. If unsuccessful in the draw, NMDGF refunds the permit fee minus a \$13.00 application fee. These fees are not included in the hunt cost listed.

GUARANTEED TAG OPTION - LANDOWNER TAGS

We have a limited amount of landowner tags to guarantee you a hunt if you do not draw a permit. If you're interested in a LANDOWNER TAG, reserve one now with a \$5,500 deposit. Landowner tags are usually gone by the time the draw results come out. Landowner tags range from \$7,500 - \$21,000.

A 50% deposit is required when you draw a tag. Any hunter who held a New Mexico big game hunting license for the previous year must fill out a harvest report by February 15.

Wounded Game Policy: In the event a big game animal is wounded, your hunt is over until the animal is found. Animals that are wounded and get away are considered yours. The Outfitter and guides will use maximum effort to recover your animal and will make all final determinations as to the ability of the Client to continue hunting if the animal is not recovered.

STEP 4: POWER OF ATTORNEY AND CONTRACT

This contract may be used for 2 consecutive years from the date of the contract and then will be updated. The license fee is paid separately to the New Mexico Department of Game and Fish and is not included in the cost of the hunt. Your hunt cost is subject to New Mexico sales tax & fees of 7.38%.

Limited Power of Attorney: Contract must be signed and dated for application to be processed
I _____, authorize HMH Outfitters to process and sign my name to applications for the draw hunt system, hunting licenses, and landowner permits in the state of New Mexico. Contract for Outfitting service: **The hunter will provide personal transportation to hunting headquarters, weapons and ammunition, and all personal articles.** Outfitter will provide covered or field accommodations, food, guide service, field dressing of game, and packing to headquarters. **Processing and shipping are the responsibility of the hunter.**
